### **Audit Presentation**

Shane Ellison, Anderson Tackman Partner, presented the City of Iron Mountain's Report of Financial Statements for the year ended June 30, 2017. He confirmed that the governmental funds are stated with accrual calculations. Alessandrini requested clarification regarding the level of water and sewer debt obligations as well as the amount of unfunded liabilities. Ellison communicated the opinion that it is not ideal to chase actuarial numbers too closely when considering unfunded liability. Stanchina noted that the pension fund's smoothing method for gains and losses causes both slower increases and decreases. He stated that the pension fund is making actuarial adjustments that would reduce its unfunded liability.

State Bank and IM-K Federal Credit Union as depositories and Multi Bank Securities and Huntington National Bank for the procurement of CD's and agencies.
