## Special Use Permit Re: 401 S. Kimberly Ave.

Stanchina submitted the request by Karen Kovars, representing a 12-Step Program Center, for a Special Use Permit for a "center for social activities" at 401 S. Kimberly Avenue and the Planning Commission's recommendation for approval.

Stanchina confirmed that on-street parking can't be reserved for individual representatives, the building would more than likely continue to not pay property taxes and parking on Kimberly Avenue would have to be reviewed.

Revord imparted the importance of offering this service in our community.

Solom indicated that the proposed use would be great for the community and that there have not been parking issues in the past.

Karen Kovars - 803 S. Kimberly Ave.

Kovars conveyed that the building will be mortgage-free, the 12-Steps Program Center will be able to apply for grants to aid in continued building upkeep and the building is currently in good condition. Alessandrini asked that the 12-Steps Program Center work with the Badinis concerning parking. Kovars thanked the City Council for their consideration of this matter.
